Overview

IBM Document Manager V8.4 provides an application level environment for advanced document management on the IBM Content Manager framework. It is designed to help you manage the entire document lifecycle, from initial creation to final disposition or archiving. All facets of a document's use, including application integration with common applications, relationship management of related

documents, lifecycle and records management, and document transitions, can be managed fully and efficiently from the IBM Document Manager user interface.

IBM Document Manager incorporates features that help address the specialized challenges of compound documents, comprised of multiple related components, are effectively handled by IBM Document Manager. As an example, a certain process may contain a procedure consisting of a word processing file, an embedded spreadsheet, and a CAD document. IBM Document Manager provides the capabilities to manage all the relationships between these dependent components, inclusive of individual versioning control.
